- III. COMMENTS: There were no comments from the audience.
- IV. RECOGNITION: Superintendent Mousalimas introduced San Joaquin County Office of Education Public Information Officers Zachary Johnson and Lauren Dinubilo citing their highly professional work on the Outlook publication. He noted that the California School Public Relations Association had recognized one of the Outlook issues with an Award of Excellence and an article featuring a Special Education student with an Award of Merit.

V. ITEMS SCHEDULED FOR INFORMATION:

- 1. Williams Uniform Complaint Quarterly Report: Superintendent Mousalimas presented the quarterly report that indicates there were no complaints received regarding the schools and programs operated by the San Joaquin County Office of Education between mid-January and mid-April.
- 2. County Superintendent of Schools Facility/Building Naming Committee Report: Superintendent Mousalimas introduced Assistant Superintendents Kathy Skeels and Janine Kaeslin reporting he had assigned them to co-chair a committee for the purpose of reviewing and providing a recommendation regarding the naming of SJCOE facilities/buildings. Ms. Skeels and Ms. Kaeslin said that the committee was comprised of representatives from each SJCOE division, who together had provided over 100 years of service to SJCOE. Committee members and years of service to SJCOE were:

Ms. Skeels and Ms. Kaeslin explained that the committee met several times over a three-month period of time and developed criteria and guidelines, as well as a nomination form, to be used by people wishing to nominate former members of the San Joaquin County Board of Education, staff members, students, alumni, or community members who have served the SJCOE educational programs and/or community in a noteworthy and exemplary manner. They explained that a nominee shall have contributed meritoriously to the long-term welfare of SJCOE and/or San Joaquin County and that nominees shall not be considered for this honor until four years after: (a) graduation from an SJCOE educational program; or, (b) final service as an SJCOE employee or member of the San Joaquin County Board of Education. The criteria and guidelines were distributed to the Board and audience and Ms. Skeels and Ms. Kaeslin reviewed the documents with the Board.

Superintendent Mousalimas noted his appreciation to the committee and said that the criteria and guidelines clarify the process and provide objective criteria for naming facilities/buildings. He added that he would use this information to update Superintendent Policy 1600 regarding this issue and that all applications submitted would be considered under the revised policy. It was suggested that once a facility or building is named, a plaque describing the work of said nominee be placed within the building so that future generations understand the relevance of the name.
