 San Joaquin County Regional Occupational Centers and Programs Annual Report: Superintendent Mousalimas introduced Chris Kleinert and Julie Jansen, administrators in the Career Technical Education Department who presented the 2014 – 2015 Annual Report for Regional Occupational Center and Programs for review. Mr. Kleinert described the process for contacting the 1,462 students who answered the survey and had taken part in the ROC/P programs at the San Joaquin County Office of Education or the school districts in the county.

Next Mr. Kleinert shared information about the future of Career Technical Education and said there is a high level of demand for logistics and transportation positions in this area. He reported that San Joaquin County Office of Education, along with school districts in Escalon, Linden, Ripon, and Lammersville, had received grant funding to implement programs that would support this demand.

Ms. Jansen discussed the CalWorks adult programs that provide courses in the areas of warehouse training, culinary arts, construction technology, and office technology education. She said that these courses include classroom instruction and on-the-job training opportunities that provide students with a certificate of completion, which opens the door to future employment in those areas.
