I. CALL TO ORDER:

President Thiel called the meeting to order at 12:00 p.m. Board member Gebhardt led the Pledge of Allegiance.

II. ADDITIONS TO THE AGENDA: There were no additions to the agenda.

III. COMMENTS:

 Leo Bennett-Cauchon, a Special Education teacher and resident of the Manteca Unified School District, proclaimed he is under administrative leave right now due to allegations of his touching a student. He said that he comes to the County Board because this student was in county programs prior to attending Manteca Unified School District programs and the issues he is wrestling with are a policy he believes the County Board should consider. He stated that he believes his behavior falls within the guidelines of the student's IEP, the wishes of the parents, and the needs of a nonverbal student. Mr. Bennett-Cauchon said he has no criticism of county programs but believes the Management of Assaultive Behavior (MAB) training utilizes 15-year old techniques and could be updated to develop more current and appropriate responses between students and teachers. He also urged the County Board to review access protocol. He noted it is his belief that parents should be allowed to see their students in the classroom for brief periods of time rather than having absolutely no access during the school day. He indicated a review of all these processes together might provide an appropriate balance of physical contact with students that is meant to be caring and supportive.

IV. ITEMS SCHEDULED FOR INFORMATION:

1. Local Control Accountability Plan: Kristen Condit presented information regarding the process of California's Local Control Accountability Plan (LCAP) in preparation of what would come to the Board later this year for court and community schools, as well as the three charter schools. Ms. Condit reviewed the timelines associated with stakeholder meetings, posting of draft plans, collection of comments, the public hearings, and adoption by the County Board.

Next Ms. Condit described the LCAP support group meetings that occur once a month and bring together school district staff from both the program and business side of the LCAP. She said the information shared at these meetings includes a review of issues coming up through legislation, a review of the best practices suggested by California Department of Education, and sharing of documents to help make all involved more successful in this endeavor.

Ms. Condit reviewed the SJCOE LCAP goals and said they are student related and tied to goals that come as a result of a recent Western Accreditation of Schools and Colleges review. Board members asked questions related to the process for school districts, the level of school district participation in the LCAP support group meetings, whether the districts' plan progress is being tracked, and what level of professional development and training is part of district plans. The Board thanked Ms. Condit and Ms. Steinkamp for their good work.
