I. CALL TO ORDER:

Vice-President Vogel called the meeting to order at 12:00 p.m. and led the Pledge of Allegiance.

II. ADDITIONS TO THE AGENDA: There were no additions to the agenda.

III. COMMENTS:

- Mark Thiel expressed his thanks and gratitude for the opportunity to serve the students of San Joaquin County as a former County Board member who resigned in April and would have termed out in June of this year. He opined that the remedy to a situation in which a board member moves out of his/her area of representation during the term of their election is outlined in Civil Code of Procedure section 803 -811; quo warranto action. He added that if any compensation said elected official receives prior to this action has been rightfully and lawfully earned.
- Manuel Casillas introduced himself and informed the Board he plans to submit an appeal for an adult charter school that predominately services the initiatives in AB 109.
- Michelle Harris, the parent of a 4-year old who attends a Special Day program at Stella Brockman School, introduced herself and discussed the subject of mainstreaming special needs students into regular education classrooms. She shared her opinion that to be truly effective the process should include student support services, teachers, and administrators to help students adapt to their new environment.

IV: RECOGNITION:

 The Venture Academy Mock trial team and coaches were introduced and recognized for their fifth-place finish at the Empire World Mock Trial Championship held recently in New York City.

V. PUBLIC HEARING:

1. Charter School Petition Renewal: Assistant Superintendent Janine Kaeslin reported that the **one**.Charter School petition renewal is before the Board for consideration of renewal. She explained that the initial petition was approved in 2009, the school opened in 2010 at one location with a visual performing arts focus, petition renewal was approved in 2014, and now, it is up for its second renewal this fiscal year. Ms. Kaeslin introduced County Operated Schools and Programs Director Heidi Reyes, who provided information about the growth of the charter school, the programs provided, and introduced students who are enrolled at the school sites and enjoying successful progress.

Superintendent Mousalimas reported that San Joaquin County Office of Education (SJCOE) staff, led by Associate Superintendent Troy Brown would be reviewing the petition using the evaluation matrix and will provide a recommendation at the January meeting.

Board member Dyk asked questions regarding the location of the school sites under this charter petition.

Vice-President Vogel then opened the public hearing. There were no comments from the audience and the public hearing was closed.

VI. ITEMS SCHEDULED FOR INFORMATION:

California Mathematics Placement Act of 2015 Report: County Operated Schools and Programs Director Lauren Dinubilo reported that a requirement of the California Mathematics Placement Act is to examine the aggregate pupil placement data annually and report the results of the examination to the board of education in order to ensure that students are not held back in a disproportionate manner on the basis of their race, ethnicity, gender, or socioeconomic background. Ms. Dinubilo explained that the four indicators used to determine appropriate placement include diagnostic test results, grades, CAASPP scores, and teacher recommendations. She reported that the data reviewed indicates appropriate placement and results for each student. Ms. Dinubilo went on to explain that low test scores are being addressed following the assessment by the use of foundational skills modules that will fill in the learning gaps so that students can perform better in their math classes.
