I. CALL TO ORDER:

President Ottesen called the meeting to order at 12:00 p.m. Board member Dyk led the Pledge of Allegiance.

• County Operated Schools and Programs Director Heidi Reyes presented the **one.**Charter renewal petition for review. She reported that the charter school began in 2009, was renewed in 2014, and the current petition will expire in June 2019.

IV. RECOGNITION:

• Dr. Sheri Coburn, director of comprehensive health, at San Joaquin County Office of Education was recognized for receiving the 2018 William A. Howe Award for Excellence in School Health. Dr. Coburn has been an employee of the San Joaquin County Office of Education (SJCOE) since 1997 and was the 80th individual to receive this award since its inauguration in 1941. This award recognizes individuals for outstanding contributions and distinguished service in school health. Mr. Mousalimas and the Board commended Dr. Coburn for her service.

1. Dashboard Report: Assistant Superintendent Janine Kaeslin, presented the California Dashboard Local Educational Agency Indicators for SJCOE. She explained that these are specific indicators for priority areas that are not collected at the state level. Ms. Kaeslin reviewed talking points pertinent to appropriately assigned teachers, access to curriculum-aligned instructional materials, and safe, clean and functional school facilities for Priority 1; Self-reflection tools for implementation of state academic standards and parent engagement for Priorities 2 and 3; School climate for Priority 6; Self-Reflection Tool in terms of access to a Broad Course of Study for Priority 7; coordination of services for expelled students for Priority 9; and, coordination of services for foster youth for Priority 10. Ms. Kaeslin reported that the program met the performance standard for each of these priorities. Mr. Mousalimas and the Board commended Ms. Kaeslin and her team for their good work and efforts to provide assistance to students in their program.
