COMMENTS: one.Program teacher and bargaining chair Robin Reynolds spoke on behalf of educators and the community and shared their concern with the Board meetings being held at a time when most stakeholders are unable to attend. Mr. Reynolds spoke to item seven on the agenda, 2024 - 2025 School Calendars, and shared that the scheduled spring break would create a hardship for teachers and families. He advised the San Joaquin County Board of Education to send the calendars back to the unions for review.

The following email was received and read into the minutes by Marlene Acosta:

Good morning,

My name is Farron Moore & this is my 10th year as an alternative education teacher for SJCOE. I am emailing my concerns to you regarding our school calendar for the 2024/2025 school year.

Looking at the calendar for next year, I notice that it does not align with what districts around us are using. The majority of districts we pull from are moving to a spring break in the middle of March & their students have Good Friday & the Monday after Easter as a holiday. Over the last 10 years, I have had multiple times where students have missed school because their other sibling(s) in the surrounding districts are on break & they are not. My students are already behind so this time away during break causes them to fall further behind. We are also loosing out on ADA when they are not present because we do not have the work samples to show for during this time. Not only will the spring break be effected, but the Thanksgiving break as well where you have scheduled school on Monday & Tuesday.

Furthermore, these breaks not aligning with our surrounding districts causes a hardship on teachers. Many of us have school-aged (or younger) children. It means we have to pay for childcare or take the time off from work. This has a ripple effect & will be a hardship for SJCOE. We are already lacking in the area of subs & now we will have classrooms with sub jobs unfulfilled. Will administration be filling these jobs?

I truly hope you will listen to our concerns & take them into consideration. At times, it feels like the county is more worried about ADA than what will be beneficial to their students, their families, & their teachers.
