I. CALL TO ORDER:

President Gebhardt called the meeting to order at 12:00 p.m. Board member Vogel led the Pledge of Allegiance.

- II. ADDITIONS TO THE AGENDA: There were no additions to the agenda.
- III. COMMENTS: Board member Greg Clark noted that on May 17, 1954, the U.S. Supreme Court passed down Brown vs. Board of Education of Topeka, Kansas which ruled that U.S. state laws establishing racial segregation in public schools are unconstitutional, even if the segregated schools are otherwise equal in quality.
- IV. RECOGNITION: Superintendent Brown and the San Joaquin County Board of Education presented the Public Information Office with certificates recognizing them for receiving the California School Public Relations Association (CalSPRA) Communications Award for the 2022 Annual Report.

V. ITEMS SCHEDULED FOR INFORMATION:

1. TEAM Charter School Update: Associate Superintendent Janine Kaeslin reviewed the approval process of the TEAM Charter School Renewal Charter Petition that was conditionally approved on April 21, 2021, by the San Joaquin County Board of Education and shared an overview of continued progress over the last year. TEAM Charter continues to meet all deadlines and recommendations set forth in the conditional approval and is free of audit findings. Ms. Kaeslin introduced TEAM Charter's Executive Director Angela Phillips.

As part of TEAM Charter's annual update, Ms. Phillips, along with Leon Madison and Kurtis Obispo, shared a PowerPoint detailing student demographics; increased

English Language Profesionery Indicator (ELPI), scores: suspension data: continued student

English Language Proficiency Indicator (ELPI) scores; suspension data; continued student improvement in math and English learning; professional development; supplemental support for students; special education i-Ready data; chronic absenteeism rates; enrollment; and family engagement.

2. 2023 - 2024 Budget Assumptions: Deputy Superintendent Scott Anderson reviewed the details of the 2023 - 2024 budget, highlighting the key assumptions related to employee costs. Mr. Anderson explained that any employee salary adjustments, one-time payments, or changes to the health and welfare benefits cap that may result from ongoing collective bargaining will not be included in the adopted budget. These adjustments will be included in the First Interim Report as necessary and brought before the Board in December. All other statutory benefits that go with salaries are included. He indicated that for 2023 - 2024 the estimated STRS rate will remain at 19.1 percent of qualified certificated salaries, and the PERS rate is expected to be 26.68 percent of qualified classified salaries which is an increase of 1.3 percent.

Mr. Anderson reported that the May Revise report has been released and revenues are expected to be lower compared to the January projections. The May Revise proposes to fully fund the Local Control Funding Formula Cost of Living Adjustment (COLA) of 8.22 percent.

The Board thanked Mr. Anderson and his staff for their work and dedication.
