Mr. Silva shared an update on each of the four goals which were to increase student learning through challenging academics, CTE programs, and consistent instructional practices across all school sites; cultivate positive relationships between staff, students, families, and the community; by 2026-27, the graduation rate will improve by 10%, as a result of expanded tiered interventions that address the academic, behavioral, social-emotional, health and well-being needs of English learners, Homeless, Socioeconomically Disadvantaged, Students with Disabilities, African American, Hispanic, and White students; by 2026-27, the suspension rate for African American students and English learners will decrease by 10% as a result of creating a

therapeutic and restorative community at John F. Cruikshank Jr. court school, that fosters positive behavior reinforcement, restorative practices, and trauma-informed support for students.
